


#### §2301. Establishment and purposes 24

- The United States Holocaust Memorial Council is an independent estab-25
- lishment of the United States Government. The Council shall-26

- (1) provide for appropriate ways for the Nation to commemorate the 27 Days of Remembrance as an annual, national, civic commemoration of 28 29 the holocaust;
- (2) encourage and sponsor appropriate observances of the Days of Re-30 membrance throughout the United States; 31
- (3) plan, construct, and operate a permanent living memorial museum 32
- to the victims of the holocaust in cooperation with the Secretary of the 33

Interior and other departments, agencies, and instrumentalities of the United States Government as provided in section 2305 of this title; and (4) develop a plan for carrying out the recommendations of the President's Commission on the Holocaust in its report to the President of September 27, 1979, to the extent the recommendations are not otherwise provided for in this chapter.

(a) COMPOSITION.—(1) The United States Holocaust Memorial Council consists of 65 voting members and the following ex officio nonvoting members:
(A) one appointed by the Secretary of the Interior.
(B) one appointed by the Secretary of State.
(C) one appointed by the Secretary of Education.

(2) Of the 65 voting members—

(A) the President of the United States appoints 55;

(B) the Speaker of the House of Representatives appoints 5 from among members of the House of Representatives; and

(C) the President pro tempore of the Senate appoints 5, on the recommendation of the majority and minority leaders, from among members of the Senate.

(b) TERMS OF OFFICE.—(1) Except as provided in this subsection, Council
 members serve for terms of 5 years.

(2) The terms of the 5 members of the House of Representatives and the
 5 members of the Senate appointed during a term of Congress expire at the
 end of that term of Congress.

(c) CHAIRPERSON AND VICE CHAIRPERSON.—The President of the United
States shall appoint the Chairperson and Vice Chairperson of the Council
from among the members of the Council. The Chairperson and Vice Chairperson serve for terms of 5 years.


(d) VACANCIES.—(1) A vacancy on the Council shall be filled in the same
 manner as the original appointment was made.

31 (2) A member appointed to fill a vacancy occurring before the expiration 32 of the term for which the predecessor was appointed shall be appointed only 33 for the remainder of the term. A member, except a Member of Congress ap-34 pointed by the Speaker of the House of Representatives or the President pro 35 tempore of the Senate, may serve after the expiration of a term until a succes-36 sor takes office.

37 (3) The President of the United States fills a vacancy in the offices of the
 38 Chairperson and Vice Chairperson.

(e) REAPPOINTMENT.—A member whose term expires may be reappointed.
 The Chairperson and Vice Chairperson may be reappointed to those offices.

(f) PAY AND EXPENSES. (1) Except as provided in paragraph (2) of this subsection, members of the Council may be paid the daily equivalent of the 2 maximum annual rate of basic pay payable under section 5376 of title 5 for 3 each day (including traveltime) during which they perform duties of the 4 5 Council. A member is entitled to travel expenses, including a per diem allowance, as provided under section 5703 of title 5. 6 7 (2) Members who are full-time officers or employees of the United States 8 Government or Members of Congress may not receive additional pay because 9 of their service on the Council.

10 (g) ASSOCIATED COMMITTEES.—Subject to appointment by the Chair-11 person, an individual who is not a member of the Council may be designated 12 as a member of a committee associated with the Council. The individual

13 serves without cost to the Government.


(a) APPOINTMENT AND PAY.—The Chairperson of the United States Holo-15 caust Memorial Council shall appoint an Executive Director, subject to con-16 The Margares firmation by the Council. The Executive Director may be paid with non-17 1 1445 24 appropriated funds. However, if the Executive Director is paid with appro-18 Mr. S. Miller Date priated funds, the rate of pay shall be a rate that is not more than the maxi-19 mum rate of basic pay payable under section 5376 of title 5. The Executive 20 Director serves at the pleasure of the Council. 21 (b) DUTIES AND POWERS.—The Executive Director may— 22 (1) appoint employees in the competitive service subject to chapter 51 23 and subchapter III of chapter 53 of title 5; 24 (2) appoint and fix the compensation (at a rate that is not more than 25 the maximum rate of basic pay payable under section 5376 of title 5) 26 of not more than 3 employees, notwithstanding any other law; and 27 (3) implement decisions of the Council in the manner the Council di-

§2304. Gifts, bequests, and devises of property
(a) GENERAL.—The United States Holocaust Memorial Council may so-
licit, accept, own, administer, invest, and use gifts, bequests, and devises of
property to aid or facilitate the construction, maintenance, and operation of
the memorial museum. The property and the proceeds of the property shall
be used as nearly as possible in accordance with the terms of the gift, bequest,
or devise donating the property. Funds donated to and accepted by the Coun-
cil under this section are not considered appropriated funds and are not sub-
ject to any requirements or restrictions applicable to appropriated funds.

(b) TAX TREATMENT.—For the purposes of Federal income, estate, and gift
 taxes, property accepted under this section is deemed to be a gift, bequest, or
 devise to the United States Government.

 museum to cover the risks, in the amount, and containing the terms the Coun cil considers necessary.



When requested by Congress, the Comptroller General shall audit financial 26 transactions of the United States Holocaust Memorial Council. including 27 those involving donated funds, under generally accepted auditing standards. 28 The Council shall make available for an audit under this section all records, 29 items, or property used by the Council that are necessary for the audit. The 30 Council shall provide facilities for verifying transactions with the balances. 31 32 §2307. Administrative (a) BYLAWS.-(1) The United States Holocaust Memorial Council shall 33 adopt bylaws to carry out its functions under this chapter. 34 (2) The Chairperson of the Council may waive a bylaw when the Chair-35 person decides the waiver is in the best interest of the Council. Immediately 36 after waiving a bylaw, the Chairperson shall send written notice to every vot-37 ing member of the Council. The waiver becomes final 30 days after the notice 38 is sent unless a majority of Council members disagrees in writing before the 39 40 end of the 30-day period.

 to be appropriated for each of the fiscal years ending September 30, 1997-
