Tuesday, April 7, noon seminar speaker will be Elizabeth Kalko, National Museum of Natural History.

*How do bats detect and catch prey?*

### Abstract

I will summarize some field studies on the echolocation and hunting behavior of bats. A newly developed technology allows me to take a sequence of photographs of a foraging bat (multiflash stereophotography) and simultaneously record their echolocation signals. Studies of various bats show how echolocation behavior is linked to a bat's foraging behavior and habitat use.

**RESEARCH UPDATE****Excavations in Cerro Juan Díaz, Los Santos, Herrera Province**

Cerro Juan Díaz is situated on a prominent hill on the south bank of the La Villa River, not far from the sea. It has been known for years as a cemetery site where goldwork can be looted: hence, it currently has the appearance of a bombed field. At the behest of the National Heritage Department of the Institute of Culture, Luis Sánchez and Adrián Badilla from the Museo Nacional de Costa Rica are directing excavations, under the supervision of Richard Cooke. These are designed to evaluate the extent, stratigraphy and cultural content of the site prior to planning larger excavations. They are being assisted by Richard Nicholas, an English student, and Gustavo Tapia from Aguadulce.

The strategy has been to concentrate on cleaning huaquero pits in order to define stratigraphy, and to

sample strata with columns and small test excavations working backwards from exposed faces.

The site seems to have been occupied about 1800 BP. The earliest evidence for intensive activities is found on the top of the hill. It consists of two layers, the first of burned clay, full of brightly coloured polychrome pottery of the *Tonosí* style, and animal bones—mostly fish and white-tailed deer—and the second, a 5m-thick layer of ash, also full of pottery, animal bones and a surprisingly large number of tiny (<4 mm dia) stone beads. These were made on the site, and are similar to the beads used by Kuna ladies to wrap around their legs and arms. It looks as though the hilltop was used periodically for feasts related to the burial of rich individuals.

On the terraces below the hill and near the river, Sánchez and Badilla excavated a refuse feature that is later than the hilltop deposits. It contains a pottery remarkably similar to that found at sites near Panama City and hitherto not recorded in pristine deposits from Parita Bay. It also provides an excellent record of fishing, hunting and agricultural activities.

The occupation that is contemporary with the Spanish invasions of 1516-21 is characterized by deep shell mounds replete with crude pottery, and mangrove and intertidal bivalves and gastropods. It is likely that Cerro Juan Díaz is the locality where the Licentiate Espinosa was engaged in a battle with the Chief Parita—the town the Spanish later called Cubita, before the local population was forcibly moved to Los Santos to be instructed in the ways of the true and only faith.



## Contadora

STRI is renting a house on Contadora Island at the northern end of the Pearl Island Archipelago.

The house is operated primarily as a field station but during times of low research usage it is available for recreational visits by the STRI community. Charge: \$20/day/adult and \$10/day/children under 15. Capacity: 6 people.

### Specific Details:

Two bedrooms, double bed and twin bunk in each with inside and outside showers, storage room, 4 burner gas stove with oven and refrigerator. Right on water front with direct access to beach —25 meters from house—. Large balcony, with good north view, caretaker. Very few sandflies and mosquitos. 1½ minute walk from airport office but is very quiet.

You need to bring your own sheets, towels, etc. There are several restaurants (including one inexpensive criollo style) and a supermarket with basic necessities.

STRI alquiló una casa en Contadora en el extremo norte del Archipiélago de las Perlas. El objetivo del uso de esta casa es primordialmente como estación de campo, pero en épocas de poco uso para la investigación, está disponible para visitas recreativas para la comunidad de STRI. El costo, para adultos, es de \$20 por día y para niños menores de 15 años, \$10. Tiene capacidad para 6 personas.

La casa cuenta con dos recámaras con camas dobles y un canapé sencillo cada una, duchas dentro y fuera de la casa, estufa con cuatro quemadores con horno, y refrigeradora. La casa tiene acceso directo a la playa —a 25 metros—. Tiene balcón amplio y una buena vista al norte. También tiene un vigilante. Hay muy pocos zancudos y mosquitos. Está a 1½ minutos de la oficina del aeropuerto, pero es un lugar tranquilo.

Los visitantes deberán llevar sus propias sábanas, toallas, artículos para el baño y comida. Hay varios restaurantes (incluyendo uno de comida criolla de bajo precio) y un supermercado que vende artículos de primera necesidad.

Hay vuelos de Aeroperlas y Aerotaxi desde el Aeropuerto de Paitilla varias veces al día por \$44 viaje ida y vuelta. Hable con Mercedes Arosemena en Naos al 28-4060 para reservaciones y mayor información.
