

I came on board on 1986 and have been involved in major achievements benefiting STRI and its people, such as starting a new system in 1987, which was upgraded in 1991. Due to these changes, our auditors certified STRI as a sub-system of the Smithsonian Institution. Also, new procedures were improvised in 1988 to pay our bills in cash during the banking crisis: more than two million dollars were handled to meet the needs of personnel and vendors. Summarized reports were the result of new procedures saving time and effort to STRI and SI personnel. Decree #154 was implemented in 1994 to allow us to reimburse tax credits directly to employees. All these achievements have been possible due to the great dedication of the accounting team and the support of our superiors. I encourage all accountants to keep up their loyalty and hard work in spite of adverse circumstances. I ask you all never to be disappointed, because our efforts have never been ignore ... Se realizaron nuevos procedimientos para preparar reportes resumidos que economizaron tiempo y esfuerzos del personal de STRI y SI. El decreto 154 se ejecutó en 1994 para que el personal recibiera los créditos de sus impuestos directamente. Todos estos logros han sido posibles gracias a la gran dedicación del grupo de contadores y el apoyo de nuestros superiores. Quiero animar a todos los contadores a que mantengan su lealtad y trabajo duro a pesar de circunstancias adversas.
