





Introduction

The Prospectus presents the Institution's mission, immediate and future goals, and corresponding resource requirements. This Prospectus: Appendix supplements the Institution's Prospectus and provides, by major organization and functional groups, detailed:

- mission and program emphasis statements,
- projections of operating expenses, and
- projections of repair and restoration projects

The detailed projections of operating expenses in the Prospectus: Appendix comprise the "bottom-up" part of planning; that is, each Smithsonian organization estimates its resource requirements. The Prospectus: Appendix also presents the Institution's "top down" aggregate estimates of resource requirements in summary tables. Any differences between "top down" and "bottom up" projections reflect executive level adjustments to plans of individual organizational entities necessitated by the reality of resource constraints from an Institutional perspective.

The Office of Planning and Budget (OPB) prepares the Prospectus annually for review and approval by the Institution's Board of Regents. In addition, The Prospectus and its appendix complement the Institution's annual report, Smithsonian Year.

MISSION

The Anacostia Museum (AM) is a community and national source of information on African-American history and culture. The Museum develops and presents exhibitions, scholarly and applied research, historical documentation and interpretive and educational programs to scholars and the general public.

PROGRAM EMPHASIS FY 1992–96

AM will endeavor to educate the public about the rich history of African-Americans and increase awareness of the Anacostia Museum. The Museum also plans to develop model programs for collection and outreach programs; encourage and provide a forum for the work of emerging professionals, particularly minorities, who offer new approaches to museum work; encourage young minority students to investigate careers in museums; and develop strategies for qualitatively increasing the input from the community into museum programming.

MISSION

The Archives of American Art (AAA) is the world's largest repository of archival source materials relating to American visual arts. The Archives collects and preserves original documents, photographs, works of art on paper, and tape—recorded oral and video interviews pertinent to the history of American art. In addition to making these materials accessible to scholars, students, curators, and collectors, the Archives sponsors symposia, publications, lectures, and other programs for public audiences. The AAA has regional centers in New York, Boston, Detroit, San Francisco and Los Angeles.

PROGRAM EMPHASIS FY 1992–96

AAA will improve management of and access to the Archives holdings. The Archives will strengthen its information program to educate the public and specialized audiences about the Archives and its resources, and will develop a plan that increases the visibility of its programs.

MISSION

The Arthur M. Sackler Gallery and the Freer Gallery of Art research, exhibit, acquire, care and manage collections of Asian art. In addition, the Freer collections contain American art by artists whose work was greatly influenced by Asian art. These two museums support complementary programs for public and scholarly audiences interested in the history and development of eastern art and the cultural heritage of Asia.

PROGRAM EMPHASIS FY 1992–96

The Sackler Gallery plans to expand the education and publication program for adults and children to increase the understanding of the Asian world. In addition, the Gallery will seek to expand the curatorial staff, increase the collections acquisition program and establish an exchange program of scholars and conservators to promote research, collections management and conservation methods. The Freer Gallery, scheduled to reopen to the public in 1992, will concentrate efforts on caring for and preserving the Freer collection and the facility that houses and displays this collection. The Gallery is planning exhibits, outreach programs for the Asian community, and a training program in the Chinese Painting Conservation Studio.

MISSION

The Cooper – Hewitt National Museum of Design (CHM), through its exhibitions, educational programs and research, explores both the processes and the products of design with the interested museum goer, professional, and graduate student. The design concerns of the Museum vary, including urban planning, architecture, industrial design, landscape design, interior design, textiles, fashion, theater arts, advertising, graphic arts, and crafts. The National Museum of Design encourages "good design," explains the design process, fosters the level of discussion in related fields, and facilitates dialogue between audience and designer.

PROGRAM EMPHASIS FY 1992–96

CHM plans to identify, develop, and implement various interpretive programs and approaches in exhibitions, publications, performance arts, and lectures and symposia. The Museum will continue seeking ways to expand museum facilities through new construction and renovation of existing structures, and improve collections management with an off –site study and storage center and upgraded storage equipment. CHM also will endeavor to represent the Museum through an exhibition facility in Washington, D.C. In observance of the Institution's Columbus Quincentenary commemoration, the Museum will present an exhibition in the fall of 1992, "Global Image: the Process of Mapping," which looks at how maps document changing views of the world through the ages and how their design reflects changing technologies.

MISSION

The Hirshhorn Museum and Sculpture Garden (HMSG) develops public exhibitions, drawing from its own and other collections of modern and contemporary art. The Museum prepares catalogues relating to its exhibitions and collections, conducts research, and offers a variety of educational activities to the public.

PROGRAM EMPHASIS FY 1992-96

HMSG seeks to strengthen management of the permanent collection of the Museum. In addition, HMSG plans to acquire works for the permanent collection; provide new educational material in the form of catalogues, video and slide programs; and increase computer usage in many of the daily operations of the Museum. In observance of the Columbus Quincentenary, the Museum will feature an exhibition titled "Four Latin American Pioneers of Modernism," that contains works by 20th century Latin American artists who have explored new frontiers of expression.

MISSION

Located in Suitland, Maryland, the Museum Support Center (MSC), is a state-of-the-art facility for the care, conservation, and storage of many of the Institution's collections. The MSC houses the Conservation Analytical Laboratory and conservation and research laboratories for the National Museum of Natural History/Museum of Man and the National Museum of American History.

PROGRAM EMPHASIS FY 1992-96

The Institution will continue to purchase and install storage equipment at the Center and work toward providing optimum conditions for the preservation and study of Smithsonian collections housed there. The Institution will transfer collections from overcrowded museum conditions to the center. Plans include strengthening operations by developing automated information services for facility management, administration, and collections accountability.

MISSION

PROGRAM EMPHASIS FY 1992-96

NASM plans to improve its collections preservation program and provide quality housing for collections in storage. The Institution is planning an extension for these purposes at Dulles International Airport in Virginia. The Museum will strengthen information systems support for the Museum's object and archival collection that will permit the sharing of information by many users. NASM will increase the scope of its research in global environmental change, in Earth and planetary tectonics, and in astrophysics. In 1992, the Museum will present a major exhibition, "Where Next Columbus," as part of the Institution's Quincentenary commemoration. This exhibition will examine space exploration in the next 500 years, the solar system, and the social and scientific problems that are a part of extensive exploration.

This exhibit will examine plant, animal and disease exchanges that occurred between the Old and New Worlds transforming the landscape of the Americas.

MISSION

The Zoo (NZP) exhibits the living collection, open to the public at Rock Creek Park in Washington, D.C. and maintains the Conservation and Research Center, a major conservation, animal breeding, and research facility in Front Royal, Virginia. Through programs in education, research, conservation, and animal health, NZP serves the public and specialized audiences and promotes understanding of animal adaptations and evolution and the interaction of wildlife with the environment. The Zoo is currently transforming the animals—only zoological park into a biological park which will combine living exhibits of plants and animals with museum-type exhibits of skeletons and fossils.

PROGRAM EMPHASIS FY 1992–96

NZP will expand efforts to educate the public about biodiversity in a changing global environment through constructing new facilities and exhibits. NZP will maintain the present physical plant and modernize equipment for research, safety, and efficient operation. NZP will strengthen research in wildlife propagation and conservation biology, and expand international collaboration with other zoos. NZP will increase research into "test tube" fertilization of animal embryos and studies of molecular and population genetics. The NZP scientists will pursue, in collaboration with STRI and SERC, investigations of the recent alarming decline of migratory birds that breed in temperate forests but winter in tropical forests.

The Smithsonian Astrophysical Observatory (SAO) conducts basic research in astronomy and astrophysics and communicates this information to various scientific and other audiences through publications, teaching, and public presentations. SAO conducts its varied scientific programs in conjunction with the Harvard College Observatory; together the two Observatories form the Center for Astrophysics in Cambridge, Massachusetts.

PROGRAM EMPHASIS FY 92 - 96

The development of two important major scientific instrumentation projects is underway. These are the submillimeter wavelength telescope array and the conversion of the multiple mirror telescope to a single 6.5 meter diameter mirror. The latter is a joint project with the University of Arizona. SAO will explore alternatives for the siting and development of the submillimeter array. SAO will continue to develop research in theoretical topics and plans added technical support for all programs. At the Whipple Observatory on Mt. Hopkins Arizona, SAO will complete construction of the new base camp and develop associated visitor and research support activities.

The Smithsonian Environmental Research Center (SERC) performs basic scientific research on the ecology of coastal systems, including air, land and water questions particularly relevant to the Chesapeake Bay region. The Center is located on the Rhode River, a tidal river system of the Chesapeake Bay. Staff, visiting scientists, and students study land use, the movement of nutrients, the dynamics of plant and animal populations, and the overall health of the systems. SERC also conducts public tours and education activities for a variety of audiences.

SERC plans to augment its basic ecological and environmental science efforts by providing improved facilities, additional site locations, and other resources conducive to formulating and testing questions and hypotheses about the surrounding Bay region. SERC will continue to study man's impact on the Rhode River and compare findings from research studies elsewhere. SAO will enhance training, fellowship and internship programs and public awareness' activities to support and promote SERC's global research efforts. SERC and STRI will continue to collaborate on studies comparing the responses of temperate forest and tropical forest trees to atmospheric and soil factors.

In 1992, the SIL will organize an exhibition, "Science in the Age of Columbus," as part of the Institution's Quincentenary commemoration.

The Tropical Research Institute (STRI), with headquarters in Panama, conducts and supports research on the ecology, behavior and evolution of tropical organisms. Staff and visiting scientists' investigations encompass New and Old World tropics. A major focus of research includes viable alternatives to traditional agricultural and forest practices that contribute to deforestation of the world's tropics. STRI supports education and training in tropical biology through competitive fellowship and internship programs. STRI also fosters conservation in the tropics through its environmental education programs.

PROGRAM EMPHASIS FY 1992–96

STRI plans to increase and strengthen research studies of biological processes affecting global environmental change. In addition, STRI expects to expand opportunities for joint scholarly appointments and fellowships, and to strengthen scientific collaboration with other major research institutions worldwide. STRI plans to enhance the quality of support services critical to conducting research in Panama and similar locales.

Plans include ensuring that the Museum of the American Indian collections are accountable and accessible; and secure excellence in exhibition support operations through state-of-the-art production laboratories.
