The SPEAKER OF THE HOUSE OF REPRESENTATIVES.

SIR: I have the honor to transmit herewith for the consideration of the Congress proposed new obligational authority in the amount of \$2,225,532,300 for the fiscal year 1964 for various departments and agencies. In addition, other proposals not increasing new obligational authority are made to provide for the transfer of \$5,388,000 between appropriations and for an increase in limitation in the amount of \$120,000.

These proposals and those transmitted in the last session and now pending in the Congress are largely to provide funds for needed programs authorized by recent legislation and for other urgent requirements of the Government. I trust that the Congress will be able to act promptly on these requests.

PROPOSED SUPPLEMENTAL APPROPRIATIONS

The details of these proposed appropriations and provisions, the necessity therefor, and the reasons for their submission are set forth in the attached letter from the Director of the Bureau of the Budget, with whose comments and observations thereon I concur.

SIR: I have the honor to submit herewith for your consideration proposed supplemental appropriations and provisions for the fiscal year 1964 in the following amounts:

The transmittal of these proposed supplemental appropriations should be considered as a part of your transmittal to the Congress of your 1965 budget. Each of the requests for appropriations for the executive branch contained herein is listed as a specific item within the 1964 totals as shown in the 1965 budget. None of the requests exceeds the amount shown in the budget; some of the requests, in fact, have been reduced below the budgeted amount, the total of such reductions amounting to about \$5 million.

Moreover, all employment in the executive branch which would be financed out of these appropriations is already included in the employment totals as shown in the budget.

In other words, these supplemental requests are a part of your budget, not an addition thereto.

Of the total new obligational authority for the executive branch, \$1,564 million is to carry out legislation enacted at the last session of the Congress. The principal amounts in this category are \$865 million for the pay increases granted by the Uniformed Services Pay Act of 1963 which became effective October 1, 1963, and \$615 million for a number of education programs, including \$267 million for loans and grants to assist in the construction of facilities for higher education and \$253 million for assistance to school districts in areas affected by Federal activities. The remaining \$86 million would provide funds for changes in the manpower development and training program, for the beginning of a program to rehabilitate the territory of Guam, and for a number of other needs resulting from legislation enacted at the last session of Congress.

The total also includes requests, adding to \$535 million, for congressional reconsideration of reductions made in the President's original 1964 recommendations. The requested restorations are as follows.

\$234 million to maintain the average military strength approved by the Congress and to meet requirements for retired pay. The possible need for provision of additional funds for this purpose was recognized in the conference report on the 1964 Department of Defense Appropriation Act.

\$141 million to permit the development and procurement of long leadtime items needed to achieve the goal of a manned lunar landing within this decade.

\$160 million for public assistance grants to meet the requirements for payments to beneficiaries.

Included in the request is \$74 million to meet uncontrollable and emergency requirements such as those for the payment of unemployment compensation benefits for Federal employees and ex-servicemen, the fighting of fires in the national forests, parks, and rangelands, the payment of wage increases set by wage boards, and for payments to sugar producers as required by the Sugar Act.

The remaining \$50 million is largely for the purchase from the Treasury of \$25 million of Japanese yen for the establishment of a binational cultural foundation and \$12 million of excess foreign currencies to assist in the preservation of the ancient temples of Abu Simbel. These are transactions within the Government and do not affect its budgetary position.

The proposed supplemental appropriations and provisions for the executive branch have been carefully reviewed, and I recommend their transmission to Congress in the amounts specified. Those submitted by the legislative branch and the judiciary have been included without change.

DETAIL OF PROPOSED SUPPLEMENTAL APPROPRIATIONS FOR FISCAL YEAR 1964, AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the following sums are appropriated out of any money in the Treasury not otherwise appropriated, to supply supplemental appropriations for the fiscal year ending June 30, 1964, and for other purposes, namely:

LEGISLATIVE BRANCH

ARCHITECT OF THE CAPITOL

CAPITOL BUILDINGS AND GROUNDS

Capitol Buildings

For an additional amount for "Capitol buildings", \$20,000.

Capitol Grounds

For an additional amount for "Capitol grounds", \$4,500.

Senate Office Buildings

For an additional amount for "Senate office buildings", \$31,000.

Legislative Garage

For an additional amount for "Legislative garage", \$800.

House Office Buildings

For an additional amount for "House office buildings", \$13,000.

Capitol Power Plant

For an additional amount for "Capitol power plant", \$13,500.

LIBRARY BUILDINGS AND GROUNDS

Structural and Mechanical Care

For an additional amount for "Structural and mechanical care", \$13,000.

BOTANIC GARDEN

SALARIES AND EXPENSES

For an additional amount for "Salaries and expenses", \$4,600.

As provided by statute, these supplemental estimates for the Legislative Branch are submitted without change.

THE JUDICIARY

SUPREME COURT OF THE UNITED STATES

CARE OF THE BUILDINGS AND GROUNDS

For an additional amount for "Care of the building and grounds", \$8,900.

PROPOSED SUPPLEMENTAL APPROPRIATIONS

COURTS OF APPEALS, DISTRICT COURTS, AND OTHER
JUDICIAL SERVICES

SALARIES OF REFEREES

For an additional amount for "Salaries of referees", to be derived from the Referees' salary and expense fund established in pursuance of the Act of June 28, 1946, as amended (11 U.S.C. 68, 102), \$65,000.

As provided by statute, these supplemental estimates for the Judiciary are submitted without change.

DEPARTMENT OF AGRICULTURE

AGRICULTURAL RESEARCH SERVICE

SALARIES AND EXPENSES

For an additional amount for "Salaries and expenses", for "Meat inspection", \$590,000.

Of this proposed supplemental appropriation, \$90 thousand is needed because of a salary reclassification of meat inspector positions, and \$500 thousand because of a greater work load than was estimated in the 1964 budget request.

AGRICULTURAL MARKETING SERVICE

MARKETING RESEARCH AND SERVICE

For an additional amount for "Marketing research and service", \$173,000.

This supplemental appropriation is requested to provide for the costs of a reclassification of poultry inspector positions.

AGRICULTURAL STABILIZATION AND CONSERVATION SERVICE

EXPENSES, AGRICULTURAL STABILIZATION AND CONSERVATION
SERVICE

For an additional amount for "Expenses, Agricultural Stabilization and Conservation Service", \$13,600,000.

This supplemental appropriation is requested to meet the cost of administering the feed grain program for the 1964 crop. Legislation authorizing this program was enacted subsequent to transmittal of the 1964 budget.

SUGAR ACT PROGRAM

For an additional amount for "Sugar Act Program", \$6,400,000, to remain available until June 30, 1965.

This supplemental appropriation is requested to provide \$6,400,000 for making payments to sugar producers for greater sugar production than was anticipated.

FOREST SERVICE

FOREST PROTECTION AND UTILIZATION

For additional amounts for "Forest protection and utilization", for "Forest land management", \$13,000,000.

The Department of Agriculture has found it necessary as in past years to utilize, as authorized by law, funds appropriated for other national forest management purposes to pay emergency fire fighting costs. This proposed supplemental appropriation is to replace the

funds so used and provide funds for emergency fire fighting expenses during the remainder of fiscal year 1964.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated a necessity for a supplemental estimate of appropriation. This action was reported to the Congress by the Director of the Bureau of the Budget on December 31, 1963.

DEPARTMENT OF DEFENSE—MILITARY

MILITARY PERSONNEL

MILITARY PERSONNEL, ARMY

For an additional amount for "Military personnel, Army,"
\$258,400,000.

This supplemental appropriation is required to provide the part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963, (\$234 million) and to finance the programmed average strength of 962,995 military personnel for fiscal year 1964 (\$24.4 million). The possible need for additional funds for these purposes was recognized in the conference report on the 1964 annual appropriation act.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

MILITARY PERSONNEL, NAVY

For an additional amount for "Military personnel, Navy,"
\$245,000,000.

Additional funds are required to provide for the part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963, (\$201 million) and to finance the programmed average strength of 666,546 military personnel for fiscal year 1964 (\$44 million). The possible need for additional funds for these purposes was recognized in the conference report on the 1964 annual appropriation act.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

MILITARY PERSONNEL, MARINE CORPS

For an additional amount for "Military personnel, Marine Corps",
\$47,000,000.

This proposed supplemental appropriation is required to cover the part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

MILITARY PERSONNEL, AIR FORCE

For an additional amount for "Military personnel, Air Force", \$432,000,000.

These additional funds are required to provide for part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963 (\$286 million), and to finance the programmed average strength of 865,089 military personnel for fiscal year 1964 (\$146 million). The possible need for additional funds for these purposes was recognized in the conference report on the 1964 annual appropriation act.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

RESERVE PERSONNEL, ARMY

For an additional amount for "Reserve personnel, Army", \$500,000.

This sum is required to cover the part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

RESERVE PERSONNEL, NAVY

For an additional amount for "Reserve personnel, Navy", \$2,800,000.

Funds are required to cover the part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

RESERVE PERSONNEL, MARINE CORPS

For an additional amount for "Reserve personnel, Marine Corps", \$1,400,000.

This proposed additional appropriation is required to cover the part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

RESERVE PERSONNEL, AIR FORCE

For an additional amount for "Reserve personnel, Air Force", \$2,600,000.

These funds are required to cover the part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

NATIONAL GUARD PERSONNEL, ARMY

For an additional amount for "National Guard personnel, Army", \$8,500,000.

These funds are required to cover the part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

NATIONAL GUARD PERSONNEL, AIR FORCE

For an additional amount for "National Guard personnel, Air Force", \$3,200,000.

This sum is required to cover the part-year costs of a military pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

RETIRED PAY, DEFENSE

For an additional amount for "Retired pay, Defense", \$86,000,000.

This proposed supplemental appropriation is required for the part-year costs of a retired pay increase effective October 1, 1963, authorized by Public Law 88-132, approved October 2, 1963 (\$66 million) and to finance an average of 412,446 retired personnel for fiscal year 1964 (\$20 million).

The possible need for additional funds for these purposes was recognized in the conference report on the 1964 annual appropriation act.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

DEPARTMENT OF DEFENSE—CIVIL

DEPARTMENT OF THE ARMY

CORPS OF ENGINEERS—CIVIL

Operation and Maintenance, General

For an additional amount for "Operation and maintenance, general," \$1,700,000, to remain available until expended.

This proposed supplemental appropriation will provide funds for those wage board pay increases which have been granted since the 1964 budget estimates were prepared, and for those further increases which are anticipated to occur by the end of the fiscal year 1964.

UNITED STATES SOLDIERS' HOME

Limitation on operation and maintenance and capital outlay.

In addition to the amount otherwise available for maintenance and operation of the Soldiers' Home, \$120,000 shall be available from the Soldiers' Home permanent fund for such purposes during the current fiscal year.

This proposed increase in limitation is needed in order to provide additional funds to cover the cost of pay increases for wage-board employees granted pursuant to law.

This limitation was apportioned, pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665) on a basis which indicated a necessity for a supplemental increase in limitation. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

DEPARTMENT OF HEALTH, EDUCATION, AND WELFARE

OFFICE OF EDUCATION

EXPANSION AND IMPROVEMENT OF VOCATIONAL EDUCATION

For carrying out the provisions of the Vocational Education Act of 1963, \$60,000,000, of which \$54,000,000 shall be for grants to the States for vocational education, construction of facilities, and other services and activities as authorized by paragraphs (1), (2), (3), (4), (5), and (6) of section 4(a) and \$6,000,000 shall be for grants for the purposes of section 4(c).

This proposed appropriation will finance grants to States for expansion and improvement of vocational education, including construction of facilities, and ancillary services such as teacher training. Individuals will be trained for gainful employment as semi-skilled or skilled workers or technicians, and in business and office occupations. Support will be given to research, training, and other projects which are designed to meet the special vocational education needs of youth, particularly those in economically depressed communities who have academic, socio-economic, or other handicaps that prevent them from succeeding in regular vocational education programs. Authorization for this program is contained in Public Law 88-210 approved December 18, 1963.

HIGHER EDUCATION FACILITIES CONSTRUCTION

For grants, loans, and payments under the Higher Education Facilities Act of 1963, \$266,750,000, of which not to exceed \$230,000,000 shall be for grants for construction of academic facilities under title I; \$25,000,000 shall be for grants for construction of graduate academic facilities under title II; and \$10,000,000 shall be for loans for construction of academic facilities under title III.

This proposed appropriation is to finance (1) loans for construction of general academic facilities and (2) grants for construction of certain undergraduate facilities, including libraries, public junior colleges and technical institutes, and for graduate academic facilities. Authorization for this program is contained in Public Law 88-204, approved, December 16, 1963.

This program is designed to assist institutions in keeping abreast of enrollment which it is estimated will expand about 60 percent by 1970. Federal assistance will promote better geographic distribution of strong graduate schools which are essential to economic growth and will also stimulate the development of technical institutes to help overcome the critical shortage of manpower to assist scientists and engineers.

PAYMENTS TO SCHOOL DISTRICTS

For an additional amount for "Payments to school districts," \$216,204,000.

This proposed supplemental appropriation is to provide for payments to school districts in areas affected by Federal activities. Part C of the Vocational Education Act of 1963, approved December 18, 1963, extends the authority, which had expired on June 30, 1963, for grants for operation and maintenance of schools, paid on behalf of children whose parents work on Federal property but reside on private, taxable property.

ASSISTANCE FOR SCHOOL CONSTRUCTION

For an additional amount for "Assistance for school construction," \$36,606,000, to remain available until expended.

These funds are to permit grants for the construction of schools in areas affected by Federal activities. As in the case of the preceding item, Part C of the Vocational Education Act of 1963, approved December 18, 1963, extends authority for these payments which had expired June 30, 1963.

DEFENSE EDUCATIONAL ACTIVITIES

For an additional amount for "Defense educational activities," \$35,258,000, of which \$31,168,000 shall be for capital contributions to student loan funds and shall be available, without allotment under section 202(a), or apportionment under section 203(a), of the National Defense Education Act of 1958 (72 Stat. 1583), for payment to institutions, which have filed applications for contributions between December 14, 1962, and February 28, 1963, inclusive, and \$2,500,000 shall be for grants to States for testing, guidance, and counseling.

This proposed supplemental appropriation will provide funds for additional student loans, refilling vacated graduate fellowships, and for increased grants to States for counseling and testing programs as authorized by Part B of Vocational Education Act of 1963, approved December 18, 1963.

SALARIES AND EXPENSES

For an additional amount for "Salaries and expenses," \$960,000.

The proposed supplemental appropriation is to cover the costs of administering the Vocational Education Act of 1963, and the Higher Education Facilities Act of 1963, both of which were enacted in December 1963.

PUBLIC HEALTH SERVICE

For additional amounts for appropriations of the Public Health Service as follows, *to be derived by transfers from the appropriation for "National Heart Institute," fiscal year 1964:*

- "Accident prevention", \$18,000;
- "Chronic diseases and health of the aged", \$252,000;
- "Communicable disease activities", \$184,000;
- "Community health practice and research", \$67,000;
- "Control of tuberculosis", \$22,000;
- "Control of venereal diseases", \$19,000;
- "Dental services and resources", \$60,000;
- "Nursing services and resources", \$41,000;
- "Hospital construction activities", \$26,000;
- "Environmental health sciences", \$15,000;
- "Milk, food, interstate, and community sanitation", \$74,000;
- "Occupational health", \$49,000;
- "Radiological health", \$245,000;
- "Water supply and water pollution control", \$130,000;
- "Hospitals and medical care", \$1,331,000;
- "Foreign quarantine activities", \$108,000;
- "Indian health activities", \$737,000;
- "Biologics standards", \$30,000;
- "Salaries and expenses, Office of the Surgeon General", \$49,000.

The Uniformed Services Pay Act of 1963 increased the rates of pay and certain allowances for officers of the uniformed services, including the Public Health Service, effective October 1, 1963. Additional costs of \$4,317,100 have resulted from this enactment. In addition, wage-board pay increases granted pursuant to law since transmission of the 1964 budget estimates will require \$890 thousand. It is proposed that these costs be met from funds available within the affected appropriations, together with transfers in a total amount of \$3,457 thousand from unprogramed current funds of the National Heart Institute. The provision proposed above will transfer the required funds to the appropriations concerned.

All of the above appropriations except "Biologics standards" were apportioned, pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), so as to indicate the necessity for supplemental estimates. These actions were reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

AIR POLLUTION

For an additional amount for "Air pollution", *including \$2,000,000 for grants to air pollution control agencies under section 4 of the Clean Air Act, \$2,249,000, to remain available only until June 30, 1964: Provided, That \$59,000 of this appropriation shall be derived by transfer from the appropriation for "National Heart Institute," fiscal year 1964.*

This proposed supplemental appropriation provides for implementation of the Clean Air Act, Public Law 88-206 approved December 17, 1963. The sum of \$2 million is for grants to air pollution control agencies for the cost of developing, establishing, or improving

programs for the prevention and control of air pollution. The remainder of the funds are requested to carry out the newly authorized operating responsibilities of the Federal Government for abating and controlling air pollution.

The transfer of \$59 thousand from the National Heart Institute is to cover the cost of the pay increases granted by the Uniformed Services Pay Act of 1963.

This appropriation was apportioned, pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated a necessity for a supplemental appropriation for these statutory pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

SAINT ELIZABETHS HOSPITAL

SALARIES AND EXPENSES

The total amount made available for "Salaries and expenses" in the "Departments of Labor, and Health, Education, and Welfare Appropriation Act, 1964," is hereby increased from \$27,413,000 to \$27,909,000.

This proposal will increase the appropriation from the general fund by \$462 thousand and anticipates the use of \$34 thousand of increased reimbursements. The increase is necessary to meet the cost of (1) pay increases for wage board employees granted pursuant to law (\$439 thousand); and (2) partial year costs of medical officer pay increases pursuant to Public Law 87-793 and Executive Order 11073, dated January 2, 1963 (\$57 thousand).

This appropriation was apportioned, pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665) on a basis which indicated a necessity for a supplemental estimate of appropriation for these statutory and wage board pay increases. The action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

WELFARE ADMINISTRATION

BUREAU OF FAMILY SERVICES

Grants to States for Public Assistance

For an additional amount for "Grants to States for public assistance", \$159,600,000.

For fiscal 1964 the Congress appropriated \$2,725 million for grants to States for old-age assistance and medical assistance for the aged, aid to families with dependent children, aid to the blind, and aid to the permanently and totally disabled under titles I, IV, X, and XIV, respectively, of the Social Security Act, as amended, or for assistance payments made under title XVI of the Act, as amended. Requirements for these programs are determined in accordance with formulae prescribed by law. Current program trends indicate that an additional appropriation of \$159.6 million will be needed in order to meet program requirements during this fiscal year.

This appropriation was apportioned, pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental estimate. This action was reported to the Congress by the Director of the Bureau of the Budget on November 22, 1963.

DEPARTMENT OF THE INTERIOR

BUREAU OF LAND MANAGEMENT

MANAGEMENT OF LANDS AND RESOURCES

For an additional amount for "Management of lands and resources", \$2,500,000, of which \$335,000 shall be derived by transfers from appropriations for the fiscal year 1964, as follows:

BUREAU OF INDIAN AFFAIRS

RESOURCES MANAGEMENT

For an additional amount for "Resources management," \$500,000, of which \$60,000 shall be derived by transfer from the appropriation for "Management and investigations of resources", Bureau of Sport Fisheries and Wildlife, fiscal year 1964.

These proposed supplemental appropriations are to cover fire suppression costs incurred during the summer of 1963 and anticipated for the remainder of the current fiscal year.

These appropriations were apportioned, pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), so as to indicate the necessity for supplemental estimates for this purpose. These actions were reported to the Congress by the Director of the Bureau of the Budget on August 23, and December 4, 1963, for the item for Bureau of Land Management, and on August 24 for the appropriation "Resources management."

REVOLVING FUND FOR LOANS

For an additional amount for payment to the "Revolving fund for loans", for loans as authorized by Public Law 88-168, approved November 4, 1963, \$900,000.

Recently enacted legislation authorized loans to Indian tribes for hiring expert assistance in connection with claims presented to the Indian Claims Commission. The proposed supplemental appropriation will make funds available for loans to tribes which do not have money to employ the assistance necessary for the preparation of their cases before they can be handled by the Commission.

NATIONAL PARK SERVICE

MANAGEMENT AND PROTECTION

For an additional amount for "Management and protection", including not to exceed \$10,000 for travel and transportation of persons, \$275,000.

This proposed supplemental appropriation is to cover fire suppression costs incurred during the summer of 1963 and to meet anticipated needs for the remainder of the current fiscal year.

This appropriation was apportioned, pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), so as to indicate

the necessity for supplemental estimates for this purpose. This action was reported to the Congress by the Director of the Bureau of the Budget on December 31, 1963.

MAINTENANCE AND REHABILITATION OF PHYSICAL FACILITIES

For an additional amount for "Maintenance and rehabilitation of physical facilities", \$400,000.

This supplemental appropriation is to cover the cost of pay increases for wage-board employees granted pursuant to law.

This appropriation was apportioned, pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated a necessity for a supplemental estimate for these pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

CONSTRUCTION

For an additional amount for "Construction", *for acquisition of lands, interests therein, improvements, and related personal property*, \$3,700,000, to remain available until expended.

This proposed supplemental appropriation will enable the National Park Service to continue rapid progress in acquiring land at the Point Reyes National Seashore, California, in keeping with the intent of the Congress expressed in the law establishing the seashore. Prompt acquisitions will avoid higher prices.

OFFICE OF TERRITORIES

ADMINISTRATION OF TERRITORIES

For an additional amount for "Administration of Territories", *for loans and grants as authorized by Public Law 88-170, approved November 4, 1963*, \$11,464,000.

Legislation enacted by the last session of Congress authorized loans and grants up to \$45 million for the rehabilitation of the territory of Guam. The loans and grants will be used to replace public facilities destroyed by a very severe typhoon in 1962 and also to replace other obsolete temporary facilities constructed in the Second World War. Water, power, and telephone projects will be financed from loans repayable in full with interest. All other projects will be financed 50% from loans and 50% from grants.

The requested supplemental is to make the first funds available to proceed with this program.

DEPARTMENT OF JUSTICE

LEGAL ACTIVITIES AND GENERAL ADMINISTRATION

FEES AND EXPENSES OF WITNESSES

For an additional amount for "Fees and expenses of witnesses", *including an additional amount of not to exceed \$50,000 for compensation and expenses of witnesses (including expert witnesses) or informants*, \$400,000.

Additional funds are needed to cover increased payments of compensation and expenses of witnesses. Requirements during the first 6 months were approximately 20 percent greater than were provided for in the 1964 appropriation.

PROPOSED SUPPLEMENTAL APPROPRIATIONS

FEDERAL PRISON SYSTEM

SALARIES AND EXPENSES, BUREAU OF PRISONS

For an additional amount for "Salaries and expenses, Bureau of Prisons", \$201,000.

This proposed supplemental appropriation is to cover the cost of pay increases for wage-board employees granted pursuant to law.

SUPPORT OF UNITED STATES PRISONERS

For an additional amount for "Support of United States Prisoners", \$200,000.

This proposed supplemental appropriation is to enable the prison system to meet the increased charges made by State and local institutions for housing and feeding Federal prisoners during temporary stays.

DEPARTMENT OF LABOR

OFFICE OF MANPOWER, AUTOMATION, AND TRAINING

MANPOWER DEVELOPMENT AND TRAINING ACTIVITIES

For an additional amount for "Manpower development and training activities", \$55,000,000.

This proposed supplemental appropriation will finance the recently enacted legislation amending the Manpower Development and Training Act. These amendments provide for the postponement of matching funds by the States until the fiscal year 1966, for increased benefit allowances, literacy training, relocation allowances and other changes, and will permit the approval of additional training projects to train a substantially larger number of unemployed and underemployed workers. It is estimated that under currently available funds no new training projects could be approved subsequent to February 1, 1964.

BUREAU OF EMPLOYMENT SECURITY

UNEMPLOYMENT COMPENSATION FOR FEDERAL EMPLOYEES AND EX-SERVICEMEN

For an additional amount for "Unemployment compensation for Federal employees and ex-servicemen", \$30,000,000.

Additional funds are needed this year to finance increased unemployment compensation benefits resulting from increased salary levels and a higher rate of claims than was anticipated in the original estimate.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated a necessity for a supplemental estimate. This action was reported to the Congress by the Acting Director of the Bureau of the Budget on December 30, 1963.

COMPLIANCE ACTIVITIES, MEXICAN FARM LABOR PROGRAM

For an additional amount for "Compliance activities, Mexican farm labor program", \$430,000.

SALARIES AND EXPENSES, MEXICAN FARM LABOR PROGRAM

For an additional amount for "Salaries and expenses, Mexican farm labor program", \$165,000, which shall be derived by transfer from the farm labor supply revolving fund.

The recent enactment of legislation extending the Mexican farm labor program from December 31, 1963, to December 31, 1964, necessitates provision of additional funds to finance these activities through June 30, 1964. It is estimated that approximately 83,000 Mexican workers will be admitted under the program between January 1, 1964, and June 30, 1964.

BUREAU OF EMPLOYEES' COMPENSATION

EMPLOYEES' COMPENSATION CLAIMS AND EXPENSES

For an additional amount for "Employees' compensation claims and expenses", \$5,000,000.

This additional amount is needed to finance increased benefit payments resulting from increased salary levels and to cover the increased cost of medical services for injured Federal employees. These factors have had a greater impact than was anticipated in the original 1964 estimate.

DEPARTMENT OF STATE

ADMINISTRATION OF FOREIGN AFFAIRS

SALARIES AND EXPENSES

For an additional amount for "Salaries and expenses", \$5,000,000.

This proposed supplemental appropriation is to improve the State Department's communications system. It would provide more secure equipment and facilities, and the additional staff necessary for the adequate operation and management of the system.

EMERGENCIES IN THE DIPLOMATIC AND CONSULAR SERVICE

For an additional amount for "Emergencies in the diplomatic and consular service", \$400,000.

This supplemental appropriation is to finance unanticipated expenses arising in the conduct of foreign affairs.

EDUCATIONAL EXCHANGE

PRESERVATION OF ANCIENT NUBIAN MONUMENTS (SPECIAL FOREIGN CURRENCY PROGRAM)

For payments in foreign currencies, which the Treasury Department determines to be excess to the normal requirements of the United States, to the United Nations Educational, Scientific, and Cultural Organization for the preservation of the ancient temples of Abu Simbel, as authorized by the Mutual Educational and Cultural Exchange Act of 1961 (75 Stat. 527), as amended, \$12,000,000, to remain available until expended.

This appropriation will make possible a grant to the United Nations Educational, Scientific and Cultural Organization of foreign currencies, excess to the requirements of the United States, for the preservation, through dismantling and re-erection on another site, of the two ancient temples of Abu Simbel. The present site will be submerged by the rising waters of the Aswan Dam basin. The appropriation,

which would provide for the purchase from the Treasury Department of foreign currencies owned by the United States, would not involve additional expenditures.

The appropriation is needed at this time in order to provide funds for payment of work begun under the contract signed November 16, 1963.

EDUCATIONAL AND CULTURAL EXCHANGE WITH JAPAN

For payments in Japanese yen, which accrued pursuant to the Agreement between the United States and Japan Regarding the Settlement of Postwar Economic Assistance to Japan, to carry out a program of educational and cultural exchange under the provisions of the Mutual Educational and Cultural Exchange Act of 1961 (75 Stat. 527), \$25,000,000, to remain available until expended; Provided, That this paragraph shall be effective only upon the execution of an agreement between the United States and Japan to establish a bi-national foundation to carry out the foregoing program.

Under the terms of the Agreement between the United States and Japan Regarding the Settlement of Post-War Economic Assistance and the exchange of notes of January 9, 1962, which accompanied this Agreement, the United States is committed to use \$25 million of yen repayments accrued as a result of this settlement for purposes of educational and cultural exchange between the United States and Japan.

This appropriation would permit the establishment of a foundation to carry out, through use of income derived from investments, a program of educational and cultural exchange.

The funds are needed now to provide firm assurance of availability of funds prior to the negotiation of an agreement with Japan, to permit earliest possible investment of capital assuring greatest return, and to insure the unbroken continuation of the present binational educational exchange program with Japan.

The appropriation would be used for the purchase from the Treasury Department of foreign currency already owned by the United States and would have no net effect on the government's budgetary position.

TREASURY DEPARTMENT

OFFICE OF THE SECRETARY

SALARIES AND EXPENSES

For an additional amount for "Salaries and expenses", \$29,000, to be derived by transfer from the appropriation for "Salaries and expenses", Office of the Treasurer, fiscal year 1964.

This proposed supplemental appropriation is required to cover the cost of pay increases granted wage-board employees pursuant to law.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental estimate for this purpose. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

BUREAU OF CUSTOMS

SALARIES AND EXPENSES

For an additional amount for "Salaries and expenses", \$115,000, to be derived by transfer from the appropriation for "Salaries and expenses", Office of the Treasurer, fiscal year 1964.

These additional funds are required to cover the cost of pay increases granted wage-board employees pursuant to law.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental estimate for this purpose. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

BUREAU OF THE MINT

SALARIES AND EXPENSES

For an additional amount for "Salaries and expenses", \$500,000, to be derived by transfer from the appropriation for "Salaries and expenses", Office of the Treasurer, fiscal year 1964.

This proposed supplemental appropriation is to provide for an increase in the production of coins over that contemplated in the 1964 budget. The demand for coins continues to be extremely heavy. Despite a record production in fiscal year 1963 of 3,627 million coins, the Mint must increase production over that contemplated for 1964 in order to meet the demand. The additional funds requested will allow the Mint to produce 250 million additional coins.

This supplemental is in addition to the request of \$675 thousand now pending before the Congress to provide for the production of silver dollars.

COAST GUARD

OPERATING EXPENSES

For an additional amount for "Operating expenses", \$10,800,000.

This proposed supplemental appropriation is required to cover the costs of Public Law 88-132, the Uniformed Services Pay Act of 1963, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental estimate for this purpose. This action was reported to the Congress by the Director of the Bureau of the Budget on December 11, 1963.

RETIRED PAY

For an additional amount for "Retired pay", \$1,125,000.

These funds are required to cover the costs of Public Law 88-132, the Uniformed Services Pay Act of 1963, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental estimate for this purpose. This action was reported to the Congress by the Director of the Bureau of the Budget on December 11, 1963.

RESERVE TRAINING

For an additional amount for "Reserve training", \$700,000, to be derived by transfer from the appropriation for "Salaries and expenses", Office of the Treasurer, fiscal year 1964.

This proposed supplemental appropriation is required to cover the costs of Public Law 88-132, the Uniformed Services Pay Act of 1963, approved October 2, 1963.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental estimate for this purpose. This action was reported to the Congress by the Director of the Bureau of the Budget on December 11, 1963.

GENERAL SERVICES ADMINISTRATION

REAL PROPERTY ACTIVITIES

OPERATING EXPENSES, PUBLIC BUILDINGS SERVICE

For an additional amount for "Operating expenses, Public Buildings Service," \$2,338,000.

This proposed supplemental appropriation is required to cover the costs of pay increases for wage board employees granted pursuant to law.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated the necessity for a supplemental estimate for this purpose. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

HOUSING AND HOME FINANCE AGENCY

OFFICE OF THE ADMINISTRATOR

PUBLIC WORKS PLANNING FUND

For an additional amount for the "Public works planning fund", \$1,000,000, together with such additional sums not to exceed \$3,000,000 as may be necessary to restore to said revolving fund the amounts which are not required to be repaid pursuant to section 702(g) of the Housing Act of 1954, as added by section 6 of the Public Works Acceleration Act (40 U.S.C. 462g).

Section 6 of the Public Works Acceleration Act provides that no advance made under section 702 of the Housing Act of 1954 for the planning of any public works project shall be required to be repaid if construction of such project is initiated as a result of a grant-in-aid made under the Public Works Acceleration Act. Approximately \$1 million of such advances have already been forgiven under this provision and it is estimated that an additional \$3 million will be forgiven before the end of 1964. An appropriation to restore the amounts forgiven will bring the public works planning fund back to the \$58 million level authorized by law and provide funds to cover new approvals of advances.

NATIONAL AERONAUTICS AND SPACE ADMINISTRATION

RESEARCH AND DEVELOPMENT

For an additional amount for "Research and Development", \$141,000,000, to remain available until expended.

These additional funds are needed to continue the development and procurement of certain long leadtime items at the rate required, so that the manned space flight program may go forward to achieve the goal of a manned lunar landing within this decade. The principal items requiring additional amounts in 1964 are the lunar excursion module and associated components of the Apollo spacecraft, \$31 million, and the Saturn V launch vehicle, \$110 million.

VETERANS ADMINISTRATION

MEDICAL CARE

For an additional amount for "Medical care", \$10,579,000.

This proposed supplemental appropriation is required to meet the cost of pay increases for wage-board employees granted pursuant to law.

This appropriation was apportioned, pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665), on a basis which indicated a necessity for a supplemental appropriation for wage-board pay increases. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

CONSTRUCTION, CORREGIDOR-BATAAN MEMORIAL

For planning and constructing a memorial on Corregidor Island, as authorized by the Act of August 5, 1953, as amended (36 U.S.C. 426), \$1,500,000 to remain available until expended.

Public Law 88-240 approved December 23, 1963, authorized an appropriation to the Veterans Administration for the construction of a battlefield type memorial on Corregidor Island. The sum of \$1.5 million, the total amount authorized, will provide for necessary planning and design expenses in fiscal year 1964 with actual construction commencing in fiscal year 1965.

HISTORICAL AND MEMORIAL COMMISSIONS

CORREGIDOR-BATAAN MEMORIAL COMMISSION

For expenses necessary to carry out the provisions of the Act of August 5, 1953, as amended (36 U.S.C. 426), \$11,000, to remain available until expended.

The Corregidor-Bataan Memorial Commission was established by Public Law 193, 83d Congress, to plan a memorial to be erected on Corregidor Island to commemorate veterans who fought under the American flag in the Pacific area during World War II. Construction was to be financed by public subscription. Public Law 88-240, approved December 23, 1963, amended prior statutes and authorized appropriation of \$1.5 million to the Veterans Administration for construction of a battlefield memorial. This supplemental appropriation is required to provide for necessary expenses of the Commission for the remainder of 1964 in connection with coordination and planning for the development of the memorial as now authorized.

SMITHSONIAN INSTITUTION

SALARIES AND EXPENSES

For an additional amount for "Salaries and expenses", \$67,000.

This proposed supplemental appropriation is to cover the cost of pay increases for wage-board employees granted pursuant to law.

This appropriation was apportioned pursuant to section 3679 of the Revised Statutes, as amended (31 U.S.C. 665) on a basis which indicated a necessity for a supplemental appropriation. This action was reported to the Congress by the Director of the Bureau of the Budget on January 20, 1964.

NATIONAL GALLERY OF ART

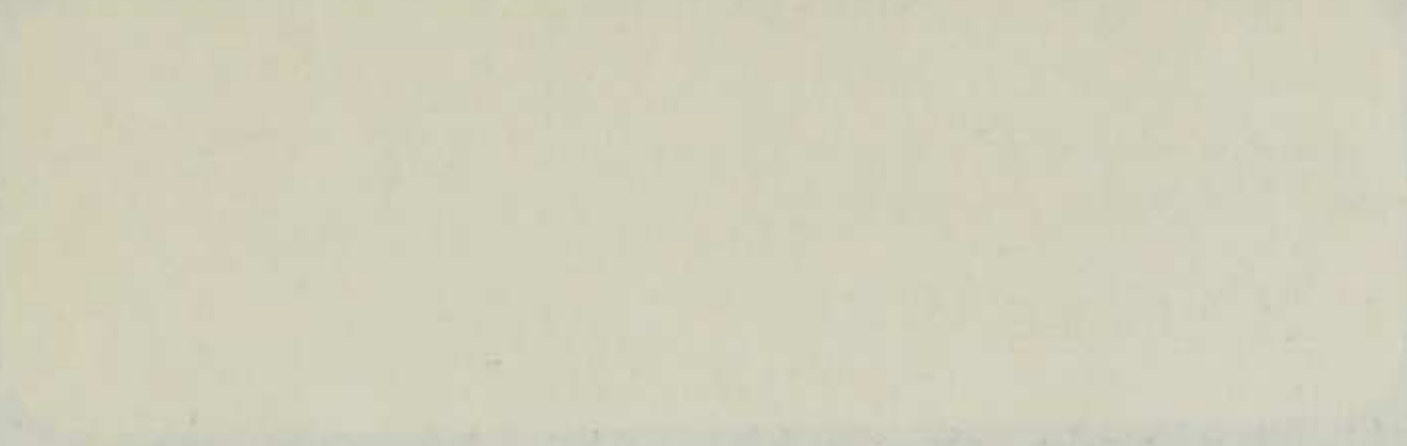

For an additional amount for "Salaries and expenses", \$38,000.

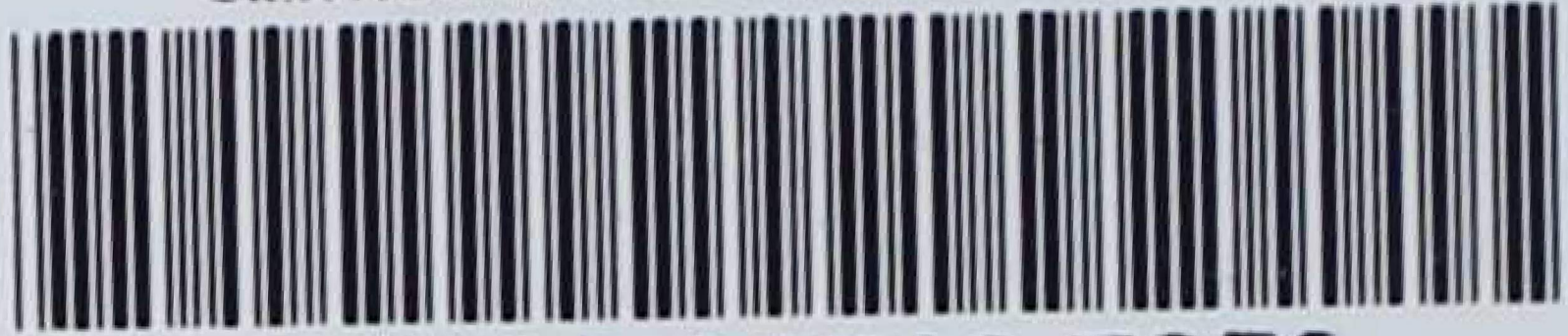
Additional funds are needed to cover the cost of pay increases for wage-board employees granted pursuant to law.
