AN ACT

Making emergency supplemental appropriations for additional disaster assistance and making rescissions for the fiscal year ending September 30, 1995, and for other purposes.

- 1 *Be it enacted by the Senate and House of Representa-*
- 2 *tives of the United States of America in Congress assembled,*
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, to pro-
- 5 vide emergency supplemental appropriations for additional
- 6 disaster assistance and making rescissions for the fiscal
- 7 year ending September 30, 1995, and for other purposes,
- 8 namely:

22 maturity, obligations of the Federal Government
23 that are included in the public debt. Any obligation
24 of the Federal Government that is paid, redeemed,

1 or bought with money from the Fund shall be can-
2 celed and retired and may not be reissued.

6 Of the funds made available under this heading in
7 Public Law 103-283, \$187,000 are rescinded.

8 **TITLE VII**
9 **GENERAL PROVISIONS**

10 SEC. 701. None of the funds made available in any
11 appropriations Act for fiscal year 1995 may be used to
12 issue, implement, administer, or enforce any executive
13 order, or other rule or order, that prohibits Federal con-
14 tracts with companies that hire permanent replacements
15 for striking employees.

16 SEC. 702. Hereafter, the requirement pursuant to
17 section 18(b)(3) of the United States Housing Act of
18 1937, for the provision of an additional dwelling unit for
19 each public housing dwelling unit to be demolished or dis-
20 posed of under an application submitted by a public hous-
21 ing agency under section 18(a) of such Act, shall not apply
22 to any such application approved by the Secretary of
23 Housing and Urban Development in fiscal year 1995 or
24 in any prior fiscal year: *Provided*, That no such application
25 submitted by a public housing agency to implement a final

1 order of a court issued, or a settlement approved by a
2 court, before the effective date of this public law, shall
3 be affected by this paragraph.

4 SEC. 703. None of the funds made available in any
5 appropriations Act for fiscal year 1995 may be used by
6 the Environmental Protection Agency to impose or enforce
7 any requirement that a State implement trip reduction
8 measures to reduce vehicular emissions.

9 SEC. 704. None of the funds made available in any
10 appropriations Act for fiscal year 1995 may be used by
11 the Environmental Protection Agency to impose or enforce
12 any requirement that a State implement an inspection and
13 maintenance program for vehicular emissions.

14 SEC. 705. The Congress finds that the 1990 amend-
15 ments to the Clean Air Act (Public Law 101-549) super-
16 seded prior requirements of the Clean Air Act regarding
17 the demonstration of attainment of national ambient air
18 quality standards and eliminated the obligation of the Ad-
19 ministrator of the Environmental Protection Agency to
20 promulgate a Federal implementation plan under section
21 110(e) of the Clean Air Act for the South Coast, Ventura,
22 or Sacramento areas of California. Upon the enactment
23 of this Act, any Federal implementation plan that has
24 been promulgated by the Administrator of the Environ-
25 mental Protection Agency under the Clean Air Act for the

1 South Coast, Ventura, or Sacramento areas of California
2 pursuant to a court order or settlement shall be rescinded
3 and shall have no further force and effect.

4 **SEC. 706. EMERGENCY TWO-YEAR SALVAGE TIMBER SALE**
5 **PROGRAM.**

6 (a) DEFINITIONS.—For purposes of this section:

7 (1) The term “emergency period” means the
8 two-year period beginning on the date of the enact-
9 ment of this section.

10 (2) The term “Federal lands” means—

11 (A) lands within the National Forest Sys-
12 tem, as defined in section 11(a) of the Forest
13 and Rangeland Renewable Resources Planning
14 Act of 1974 (16 U.S.C. 1609(a)); and

15 (B) public lands, as defined in section
16 103(e) of the Federal Land Policy and Manage-
17 ment Act of 1976 (43 U.S.C. 1702(e)).

18 (3) The term “land management plan”
19 means—

20 (A) a land and resource management plan
21 (or, if no final plan is currently in effect, a
22 draft land and resource management plan) pre-
23 pared by the Forest Service pursuant to section
24 6 of the Forest and Rangeland Renewable Re-
25 sources Planning Act of 1974 (16 U.S.C. 1604)

1 for a unit or units of the Federal lands de-
2 scribed in paragraph (2)(A); or

3 (B) a land use plan prepared by the Bu-
4 reau of Land Management pursuant to section
5 202 of the Federal Land Policy and Manage-
6 ment Act of 1976 (43 U.S.C. 1712), or other
7 multiple-use plan in effect, for a unit of the
8 Federal lands described in paragraph (2)(B).

9 (4) The term "salvage timber sale" means a
10 timber sale for which an important reason for entry
11 includes the removal of disease- or insect-infested
12 trees, dead, damaged, or down trees, or trees af-
13 fected by fire or imminently susceptible to fire or in-
14 sect attack. Such term also includes the removal of
15 associated trees or trees lacking the characteristics
16 of a healthy and viable ecosystem for the purpose of
17 ecosystem improvement or rehabilitation, except that
18 any such sale must include an identifiable salvage
19 component of trees described in the first sentence.

20 (5) The term 'Secretary concerned' means—

21 (A) with respect to Federal lands described
22 in paragraph (2)(A), the Secretary of Agri-
23 culture; and

1 (B) with respect to Federal lands described
2 in paragraph (2)(B), the Secretary of the Inte-
3 rior.

4 (b) TWO-YEAR EMERGENCY PROGRAM OF SALVAGE
5 TIMBER SALES FOR FEDERAL LANDS.—

6 (1) SALVAGE TIMBER SALES REQUIRED.—Using
7 the expedited procedures provided in subsection (c),
8 the Secretary concerned shall prepare, advertise,
9 offer, and award contracts during the emergency pe-
10 riod for salvage timber sales from Federal lands to
11 satisfy the volume requirements of paragraph (2).

12 (2) SALVAGE TIMBER SALE VOLUMES.—The
13 salvage timber sales sold under this subsection dur-
14 ing the emergency period shall contain the following
15 total timber volumes (programmed or otherwise):

16 (A) For Federal lands described in sub-
17 section (a)(2)(A)—

18 (i) not less than 3,000,000,000 board
19 feet during the first year of the emergency
20 period; and

21 (ii) not less than 3,000,000,000 board
22 feet during the second year of the emer-
23 gency period.

24 (B) For Federal lands described in sub-
25 section (a)(2)(B)—

1 (i) not less than 115,000,000 board
2 feet during the first year of the emergency
3 period; and

4 (ii) not less than 115,000,000 board
5 feet during the second year of the emer-
6 gency period.

7 (3) USE OF SALVAGE SALE FUNDS.—To con-
8 duct salvage timber sales under this subsection, the
9 Secretary concerned may use salvage sale funds oth-
10 erwise available to the Secretary concerned.

11 (c) EXPEDITED PROCEDURES FOR EMERGENCY SAL-
12 VAGE TIMBER SALES.—

13 (1) SALE DOCUMENTATION.—For each salvage
14 timber sale conducted under subsection (b) to meet
15 the minimum salvage timber sale volumes specified
16 in paragraph (2) of such subsection, the Secretary
17 concerned shall prepare a document that combines
18 an environmental assessment under section 102(2)
19 and implementing regulations of the National Envi-
20 ronmental Policy Act of 1969 (42 U.S.C.
21 4332(2)(E)) and a biological evaluation under sec-
22 tion 7(a)(2) of the Endangered Species Act of 1973
23 (16 U.S.C. 1536(a)(2)) and other applicable Federal
24 law and implementing regulations. The environ-
25 mental assessment and biological evaluation must

1 consider the environmental effects of the salvage
2 timber sale and consider the effect, if any, on threat-
3 ened or endangered species. In lieu of preparing a
4 new document under this paragraph, the Secretary
5 concerned may use a document prepared pursuant to
6 the National Environmental Policy Act of 1969 be-
7 fore the date of the enactment of this section, a bio-
8 logical evaluation written before such date, or infor-
9 mation collected for such a document or evaluation
10 if the document, evaluation, or information applies
11 to the Federal lands covered by the proposed sale.

12 (2) TIME PERIODS FOR, AND REPORTING OF,
13 SALES.—

14 (A) FIRST YEAR.—For salvage timber
15 sales conducted pursuant to subsection (b) dur-
16 ing the first year of the emergency period, the
17 Secretary concerned shall—

18 (i) offer sales which contain fifty per-
19 cent of the total timber volume required
20 pursuant to subsection (b)(2)(A)(i) or
21 (b)(2)(B)(i), as the case may be, within the
22 first 3 months of the year; and

23 (ii) offer sales which contain the re-
24 maining volume required pursuant to sub-
25 section (b)(2)(A)(i) or (b)(2)(B)(i), as the

1 case may be, evenly distributed throughout
2 the remainder of the year.

3 (B) SECOND YEAR.—For salvage timber
4 sales conducted pursuant to subsection (b) dur-
5 ing the second year of the emergency period,
6 the Secretary concerned shall—

7 (i) offer sales which contain fifty per-
8 cent of the total timber volume required
9 pursuant to subsection (b)(2)(A)(ii) or
10 (b)(2)(B)(ii), as the case may be, within
11 15 months of the date of enactment of this
12 Act, and

13 (ii) offer sales which contain the re-
14 maining volume required pursuant to sub-
15 section (b)(2)(A)(ii) or (b)(2)(B)(ii), as the
16 case may be, within the remainder of the
17 year.

18 (C) Each Secretary shall report to the
19 Committee on Resources of the House of Rep-
20 resentatives and the Committee on Energy and
21 Natural Resources of the United States Senate
22 90 days after the date of enactment of this Act
23 and on the final day of each 90-day period
24 thereafter throughout the emergency period on
25 the number of sales and volumes contained

1 therein offered during such 90 day period and
2 expected to be offered during the next 90 day
3 period.

4 (D) SPECIAL RULES FOR SECOND YEAR
5 SALES.—The Secretary concerned may begin
6 salvage sales intended for the second year of
7 the emergency period before the start of the
8 second year if the Secretary concerned deter-
9 mines that the preparation, advertisement, of-
10 fering, awarding, and operation of such sales
11 will not interfere with salvage timber sales re-
12 quired during the first year of the emergency
13 period.

14 (3) DECISIONS.—The Secretary concerned shall
15 design and select the specific salvage timber sales to
16 be offered under subsection (b) on the basis of the
17 analysis contained in the document or documents
18 prepared pursuant to paragraph (1) to satisfy the
19 applicable volume requirement in subsection (b)(2)
20 within the applicable schedule specified in paragraph
21 (2).

22 (4) SALE PREPARATION.—The Secretary con-
23 cerned shall make use of all available authority, in-
24 cluding the employment of private contractors and
25 the use of expedited fire contracting procedures, to

1 prepare and advertise salvage timber sales under
2 subsection (b) to meet the applicable schedule speci-
3 fied in paragraph (2). The provisions of section
4 3(d)(1) of the Federal Workforce Restructuring Act
5 of 1994 (Public Law 103-226) shall not apply to
6 any former employee of the Department of the Sec-
7 retary concerned who received a voluntary separa-
8 tion incentive payment authorized by such Act or ac-
9 cepts employment pursuant to this paragraph.

10 (5) COST CONSIDERATIONS.—Salvage timber
11 sales undertaken pursuant to this section shall not
12 be precluded because the costs of such activities are
13 likely to exceed the revenues derived from such ac-
14 tivities.

15 (6) EFFECT ON OTHER LAWS.—The documents
16 and procedures required by this section for the prep-
17 aration, advertisement, offering, awarding, and oper-
18 ation of any salvage timber sale subject to sub-
19 section (b) shall be deemed to satisfy the require-
20 ments of all applicable Federal laws (and regulations
21 implementing such laws) including but not limited
22 to:

23 (A) The Forest and Rangeland Renewable
24 Resources Planning Act of 1974 (16 U.S.C.
25 1600 et seq.).

1 (B) The Federal Land Policy and Manage-
2 ment Act of 1976 (43 U.S.C. 1701 et seq.).

3 (C) The National Environmental Policy
4 Act of 1969 (42 U.S.C. 4332).

5 (D) The Endangered Species Act of 1973
6 (16 U.S.C. 1531 et seq.).

7 (7) EFFECT OF SALVAGE SALES.—The Sec-
8 retary of Agriculture shall not substitute salvage
9 timber sales conducted under subsection (b) for
10 planned non-salvage timber sales.

11 (8) EFFECT ON JUDICIAL DECISIONS.—The
12 Secretary concerned may conduct salvage timber
13 sales under the authority of this section during the
14 emergency period and the first year after the end of
15 the emergency period notwithstanding any decision,
16 restraining order, or injunction issued by a United
17 States court issued before the date of the enactment
18 of this section.

19 (d) REFORESTATION OF SALVAGE TIMBER SALE
20 PARCELS.—The Secretary concerned shall plan and imple-
21 ment reforestation of each parcel of land harvested under
22 a salvage timber sale conducted under subsection (b) as
23 expeditiously as possible after completion of the harvest
24 on the parcel, but in no case later than any applicable
25 restocking period required by law or regulation.

1 (e) ADMINISTRATIVE REVIEW.—Salvage timber sales
2 conducted under subsection (b), and any decision of the
3 Secretary concerned in connection with such sales, shall
4 not be subject to administrative review.

5 (f) JUDICIAL REVIEW.—

6 (1) PLACE AND TIME OF FILING.—A salvage
7 timber sale to be conducted under subsection (b)
8 shall be subject to judicial review only in the United
9 States district court for the district in which the af-
10 fected Federal lands are located. Any challenge to
11 such sale must be filed in such district court within
12 15 days after the date of initial advertisement of the
13 challenged sale.

14 (2) EFFECT OF FILING ON AGENCY ACTION.—

15 For 45 days after the date of the filing of a chal-
16 lenge to a salvage timber sale to be conducted under
17 subsection (b), the Secretary concerned shall take no
18 action to award the challenged sale.

19 (3) PROHIBITION ON RESTRAINING ORDERS,

20 PRELIMINARY INJUNCTIONS, AND RELIEF PENDING

21 REVIEW.—No restraining order or preliminary in-

22 junction shall be issued by any court of the United

23 States with respect to any decision to prepare, ad-

24 vertise, offer, award, or operate a salvage timber

25 sale pursuant to subsection (b). Section 705 of title

1 5, United States Code, shall not apply to any chal-
2 lenge to such a sale.

3 (4) STANDARD OF REVIEW.—The courts shall
4 have authority to enjoin permanently, order modi-
5 fication of, or void an individual salvage timber sale
6 if it is determined by a trial on the merits that the
7 decision to prepare, advertise, offer, award, or oper-
8 ate such sale was arbitrary and capricious or other-
9 wise not in accordance with applicable law (other
10 than those laws specified in subsection (c)(6)).

11 (5) TIME FOR DECISION.—Civil actions filed
12 under this subsection shall be assigned for hearing
13 at the earliest possible date and shall take prece-
14 dence over all other matters pending on the docket
15 of the court at that time except for criminal cases.
16 The court shall render its final decision relative to
17 any challenge within 45 days from the date such
18 challenge is brought, unless the court determines
19 that a longer period of time is required to satisfy the
20 requirement of the United States Constitution. In
21 order to reach a decision within 45 days, the district
22 court may assign all or part of any such case or
23 cases to one or more Special Masters, for prompt re-
24 view and recommendations to the court.

1 (6) PROCEDURES.—Notwithstanding any other
2 provision of law, the court may set rules governing
3 the procedures of any proceeding brought under this
4 subsection which set page limits on briefs and time
5 limits on filing briefs and motions and other actions
6 which are shorter than the limits specified in the
7 Federal rules of civil or appellate procedure.

8 (7) APPEAL.—Any appeal from the final deci-
9 sion of a district court in an action brought pursu-
10 ant to this subsection shall be filed not later than 30
11 days after the date of decision.

12 (g) EXCLUSION OF CERTAIN FEDERAL LANDS.—

13 (1) EXCLUSION.—The Secretary concerned may
14 not select, authorize, or undertake any salvage tim-
15 ber sale under subsection (b) with respect to lands
16 described in paragraph (2).

17 (2) DESCRIPTION OF EXCLUDED LANDS.—The
18 lands referred to in paragraph (1) are as follows:

19 (A) Any area on Federal lands included in
20 the National Wilderness Preservation System.

21 (B) Any roadless area on Federal lands
22 designated by Congress for wilderness study in
23 Colorado or Montana.

24 (C) Any roadless area on Federal lands
25 recommended by the Forest Service or Bureau

1 of Land Management for wilderness designation
2 in its most recent land management plan in ef-
3 fect as of the date of the enactment of this Act.

4 (D) Any area on Federal lands on which
5 timber harvesting for any purpose is prohibited
6 by statute.

7 (h) RULEMAKING.—The Secretary concerned is not
8 required to issue formal rules under section 553 of title
9 5, United States Code, to implement this section or carry
10 out the authorities provided by this section.

11 (i) AWARD AND RELEASE OF PREVIOUSLY OFFERED
12 AND UNAWARDED TIMBER SALE CONTRACTS.—

13 (1) AWARD AND RELEASE REQUIRED.—Not-
14 withstanding any other provision of law, within 30
15 days after the date of the enactment of this section,
16 the Secretary concerned shall act to award, release,
17 and permit to be completed in fiscal years 1995 and
18 1996, with no change in originally advertised terms
19 and volumes, all timber sale contracts offered or
20 awarded before that date in any unit of the National
21 Forest System or district of the Bureau of Land
22 Management subject to section 318 of Public Law
23 101-121 (103 Stat. 745).

24 (2) EFFECT ON LAND MANAGEMENT PLANS.—
25 Compliance with paragraph (1) shall not require or

1 permit any change in any land management plan in
2 existence on the date of the enactment of this Act.
